Textual Information()	1. The Company has only 4 promoters namely Mr. Prasad Reddy Sabbella, Mr. Sharat Reddy Sabbella, Mrs Devaki Reddy Sabbella and Mrs. Charita Reddy Sabbella. 2. Further, the Company is taking necessary steps to file fresh application under Regultion 102 of SEBI (LODR) 2015 seeeking dispensation or relaxation of strict compliance with respect to Regulation 31A of SEBI (LODR) 2015 in near future for rectifying the error caused due to classification of certain public shareholders as promoters in the earlier periods in the disclosure field with Stock Exchange. In thoes disclosure filed, the total promoters were shown as more than 4 (four) inadvertently. 3. The Rights Issue Committee of the Company, by way of a Circular Resolution passed on Friday, 07th March 2025, approved the conversion of 1,36,65,888 partly paid-up equity shares into fully paid-up equity shares of face value Rs. 10/- each. Pursuant to this conversion, the Paid-Up Share Capital of the Company increased from Rs.277982812.50 to Rs.380476972.50. During the Corporate Action process for obtaining trading approval 15,496 shares were rejected, since the patly paid up shares were pledged by these shareholders and hence the debit of partly paid up shares & credit of corresponding fully paid up shares could not happen. Accordingly the company could not obtain listing & trading approval for this quantity. Subsequently, the Bombay Stock Exchange (BSE), vide its letter dated 28th March 2025, granted trading approval for 1,36,50,392 fully paid-up equity shares, effective from 01st April 2025, after excluding the rejected shares. However, the Shareholding Pattern for the quarter ended 31st March 2025 has been filed including the 15,496 shares under fully paid, since the company had already received the call money towards the same.
